The Embassy of the United States of America presents its compliments to the Ministry of Foreign Affairs of the Federation of St. Christopher and Nevis, and has the honor to inform you that on May 16, 2017, the United States designated five individuals and five entities pursuant to multiple Executive Orders (E.O.), namely E.O. 13382 ("Blocking Property of Weapons of Mass Destruction Proliferators and Their Supporters"), E.O. 13572 ("Blocking Property of Certain Persons with Respect to Human Rights Abuses in Syria"), and E.O. 13582 ("Blocking Property of the Government of Syria and Prohibiting Certain Tranactions with Respect to Syria").

As a result of these actions, all assets of these individuals and entities that are under jurisdiction of the United States or in the control of U.S. persons must be frozen, and U.S. persons are generally prohibited from engaging in transactions with them.

In addition, persons in your jurisdiction who provide material support to these and other designated individuals could themselves become subject to designation. We recommend that you convey this to any persons in your jurisdiction who transact with designated persons.

This action follows the recent action the United States took on April 24th to sanction 271 employees of the Syrian Scientific Studies and Research Center (SSRC) in response to the barbaric April 4 Sarin attack on innocent civilians by the Assad regime.

Ending the conflict in Syria is a top priority for the United States. We remain committed to holding the Assad regime accountable for its continued and blatant violation of international law. Our policy is to de-escalate the violence, ensure unhindered humanitarian access, and find a path forward to a political settlement. Lasting peace in Syria means a Syria without Bashar al-Assad, where the rights of all Syrians are protected. The United States believes in the importance of ensuring accountability for the Assad regime's atrocities.

The Embassy of the United States of America avails itself of this opportunity to renew to the Ministry of Foreign Affairs of the Federation of St. Christopher and Nevis the assurances of its highest consideration.

OFAC also designated 3 individuals, Muhammad Hasan Abbas, Samir Darwish, and Ihab Makhluf, and 3 entities, Barly Group, Al-Ajnihah, and Al-Bustan Charity, pursuant to E.O. 13572 ("Blocking Property of Certain Persons with Respect to Human Rights Abuses in Syria"), which blocks property of certain persons with respect to human rights abuses in Syria, their supporters, and supporters of senior officials or certain activities releated to public corruption. Information regarding these individuals and entities, including their identifiers, are below.

Mohammad Hassan Abbas is the maternal cousin of Rami Makhluf. Abbas has acted for or on behalf of Rami Makhluf and materially assisted, sponsored, or provided financial, material, or technological support for, or goods or services in

support of Makhluf by carrying out financial interests for Makhluf. Samir Darwish is the Director of Al-Bustan Charity and was designated for acting for or on behalf of the charity. Ihab Makhluf has materially assisted, sponsored, or provided financial, material, or technological support for, or goods or services in support of and acted or purported to act for or on behalf of, directly or indirectly, Rami Makhluf. Ihab Makhluf is the brother of Rami Makhluf and a cousin of Syrian President Bashar al-Asad.

Barly Off-Shore is a front company that is owned or controlled by Muhammad Abbas and is used to move Rami Makhluf's financial earnings out of Syria. Al-Ajnihah is owned or controlled by Muhammad Abbas and is used to move Rami Makhluf's financial earnings out of Syria. Al-Bustan is owned or controlled by Rami Makhluf, who has created a vast private network of militias and security-linked institutions through Al-Bustan. Al-Bustan is a prominent organization recruiting and mobilizing individuals to support and augment Syrian military forces.

Iyad Makhluf is the brother of Rami Makhluf and a cousin of Syrian President Bashar al-Asad. He has helped the Government of Syria evade international sanctions.
